TREASURER'S REPORT year ending 31.12.23

Figures for the year ending 31 December 2023 are overleaf alongside 2022 figures. Figures in brackets below also refer to 2022 for comparison.

Gross income for 2023 overall at £10,556 (£12,402) appears to be down by about £2,000 on 2022. It is actually up by about £200 because the 2022 accounts include the gross income on phones (£500) and the payment by HMWT for the second raft (£1,570) which together amount to about £2,000. However membership was down by 34 at 661 (695) but the donations made by members was up by an amount equivalent to the loss of membership income. Of note is the increase in bank interest which reflects the general increase in interest rates.

Expenditure was down about £1,000 of which spending on the Lake contributed about £200. Administration costs were up mainly due to both the increase in the price of stamps and the frequency of posting (6 rather than 3) following the change in the format of the newsletter in May. It also includes stamps for the Jan 2024 newsletter. The number of members not using the internet for payments and receipt of newsletters has now about 55. This number may fall a bit more over the coming years. Our (business) phone contract ended in November and the new one (for 2 years) raised the monthly cost from £9 to £12 which for unlimited calls, texts and data is still very competitive. The increase in legal fees is almost entirely due to the costs associated with the transfer of title of Ryall Island to Fosl. (This is land given to Fosl by a member). Only the cost of maintaining our fosl email addresses were incurred for our web site during 2023.

In summary FoSL's accumulated funds as at 31 Dec 2023 stood at £23,076 (£22,202) up about £870 on 2022.

Some figures for this year so far compared with this point last year

INCOME

Income is currently approx £5,300 with 557 (515)paid up members with balances standing at almost £23,400 (£24,028)This suggests that we will end the year about the same as last year

We still have about 216 names (194 households) on our database that have not yet paid for 2024. 40 of these households last paid in 2021 and will be removed from our mailing list if the reminders made between now and September do not produce a response.

There are no proposals to change the subscription for this year

EXPENDITURE

So far this year we have spent about £3,700 on the lake, about half (£1,500) for the new camera plus maintenance and £1,200 for the grazier; £1,150 on the web site for our email addresses and a two year's maintenance contract, £48 (net) on the live stream phone and £284 on insurance:
